Depending on the type of industry in which a company will carry on business, it may be necessary to notify the relevant Minister in charge of the industry concerned, in addition to the Minister of Finance, of the establishment of the branch. In such cases additional fees in relation to such notification will be charged at the rate of \$35,000 per hour. Also, in some cases,

notification to the Minister of Finance and the relevant Minister in charge of the industry concerned may be required both prior to and after its formation. In such cases, additional fees in relation to such notification will be charged at the rate of ¥35,000 per hour.

- 2. The above estimate does not include the cost (if any) for translation of any documents, if required, which are charged at the rate of \(\frac{1}{2}30,000\) per hour.
- 3. The above estimate is based on the registration of the company proceeding in a straightforward manner. Any additional work, which may be required because of unusual difficulty or unforeseen problems, will incur extra fees at the rate of \(\frac{1}{2}\)35,000 per hour.
- 4. Notification to the national and local tax offices, and any other government offices, such as for health insurance, etc., in Japan can be provided upon your request for additional fees.
- 5. Arrangements with banks can be provided upon request, and will incur extra fees at a rate of \(\frac{1}{4}\)35,000 per hour.
- 6. Arrangements for the preparation and registration of seals can be provided upon request, and will incur extra fees at a rate of \(\frac{1}{2}\)35,000 per hour.
- 7. The above estimate does not include other services on registration of a branch, including, pursuant to the Foreign Exchange Law, notification of the investment via the Bank of Japan to the Ministry of Finance, which can be provided upon request and will incur extra fees at a rate of \(\frac{\pma}{3}\)5,000 per hour.
